PRIVILEGES OF THE FLOOR

SENATOR PATRICK GALLIVAN

- PRESENTATION OF THE 2015 WOMAN OF DISTINCTION AWARD TO ELIZABETH SHERWOOD
Senator Gallivan thanked the Chairman and the Board of Supervisors. He was very happy to be here today to

recognize an individual and also to recognize the accomplishments of Livingston County in its entirety.

First he would like to recognize Betsy Sherwood. In 1998, the New York State Senate started a Women of Distinction program. They experimented during Women's History Month to honor exemplary women from around the state whether it was singular, professional, personal achievement, excellence, lifetime achievement in concern for their communities. Honorees were selected from nominations from various senators over the course of the years. Among the women honored were Susan B. Anthony and Harriet Tubman. This year, he was thrilled to nominate Betsy Sherwood of Caledonia and she was recognized on May 5, 2015 along with other women from around New York State in Albany for a wonderful ceremony with flowers and proclamations as the *Women of Distinction for the New York State Senate*. Betsy has been involved with the community for many, many years. It was very clear that Betsy was head and shoulders above the others nominations that came to his office. She has been involved with the community. She was involved in the establishment of Focus on the Children in 1993 and helped to create that organization's board, mission statement and constitution. She is currently the President of the organization, which serves children in needs throughout Livingston County. She helped establish a PTA chapter in at Caledonia-Mumford. She is joined today by her husband, Tom and Carrie Johnson from Focus on the Children. He felt that it was appropriate to recognize Betsy by this body back at home in Livingston County.

Mrs. Sherwood thanked the Board of Supervisors. She is not comfortable talking about herself, however, she is very comfortable when she gets a chance to talk about Focus on the Children. Bob Jones, her dad, was the driver behind Focus on the Children and now, some 20+ years later we are still able to carry on those missions. Last Saturday they distributed back to school supplies through their program for over 150 children. They supply everything from pencils to those \$100 calculators that kids need for trig or pre-calc. Service Coordinator, Carrie Johnson is taking phone calls on a daily basis throughout the year on an array of needs in the County. She guarantees that they are serving families in your very own communities. She has distributed their newsletter on all of the desks and asked that the Supervisors keep Focus on the Children in mind if they know of anyone in their community in need. Mrs. Sherwood thanked everyone very much for this honor.

Chairman Gott thanked Mrs. Sherwood for all that she does and congratulated her on this well deserved award.

- AMERICA'S BEST COMMUNITIES RESOLUTION PRESENTATION TO ECONOMIC DEVELOPMENT DIRECTOR JULIE MARSHALL

For everyone, past and present that contributed to our community, Senator Gallivan stated what a great privilege of his it was, to stand up on the Senate floor and brag about Livingston County as being one of the quarter finalist for America's Best Communities.
