DISCUSSION PROPOSED LOCAL LAW SIGN

Chairman Childs opened the discussion of the proposed sign local law providing a recap of the work completed to date. Many hours have been given by the Historic Preservation Commission (HPC) and they provided approximately fifty comments. The Planning Board reviewed all of the comments with appreciation of their review. The recommendation to use a modern code written by professionals such as the Honeoye Falls would have reduced the amount of time needed for review. The use of graphics, photos, and tables continue to be recommended.

Chairman Childs will provide written comments prior to the schedule Village Board public hearing later this month.

The expected life of a law is twenty to thirty years and considerable consideration would produce the best product rather than hastily written laws.

A recommendation of a complete section for lighting needs to be included.

Tonight's goals were described as compiling a bullet list of major holes. The approval of signs would be the responsibility of the Planning Board and consideration of enforceability by the Planning Board is necessary.

It was determined that a case has been made to recommend the Village Board not approve the proposed local law as there are significant issues.

Preexisting signs would not be affected by the new law. A list of historical signs will be developed by the HPC.
